

CONDITIONS FOR RESERVING A PITCH IN THE CAMP SITE

Period of reservation: from January 1st until all places have been booked.

A reservation is effective after our accordance (depending on the space available) and on receipt of your completed reservation form, signed and sent with the down payment. The down payment amounts to 40 % of the cost of your stay. Payment in several instalments is possible and free of charge.

For administrative expenses 14 € are charged. This administration fee is offered for a stay starting from 20th March to 30th June and from 20th August to 1st October.

We will send you by e-mail a confirmation of your reservation with a copy of these general conditions.

You can state your preference as to the location of a pitch. We will do our utmost to reserve this place for you, but you will understand that we cannot give you guarantees.

Every modification of dates of arrival or departure, equipments (tent, caravan, etc.) or in the make up of family members must be made in writing (letter, fax or e-mail) before the beginning of your stay.

Every reservation is personal and cannot be yielded to anyone else.

If no message is received warning us of a late arrival, the pitch will be reset 1 day after the projected arrival date.

Reservation is not compulsory. As long as space is available we will welcome you without a reservation.

All people using a pitch are obliged to comply with the enclosed rules of the camp site.

Cancellation before the arrival date: The campsite will not refund the down payment.

Delayed arrival - Early departure: please give the EXACT DATES of your arrival and departure. You will be charged for the full period of reservation, whatever your reasons of an early departure.

We therefore strongly advise you to subscribe to our cancellation and curtailment insurance « Campez Couvert » by Gritchen Affinity. In case of curtailment of your stay your non-used days will be refunded, your down payment will be refunded in case of cancellation (Except administrative expenses, except the insurance premium, an excess and according to the General cancellation terms).

Cancellation and curtailment insurance « Campez Couvert » by Gritchen Affinity:
